

RECORD OF MEETING AT UNITING CHURCH HALL, KATOCMBA ST., KATOCMBA, ON AUGUST 4, 1991

Record of last meeting was accepted by all present.

Core Membership

Carolyn Williams from CORE(Coalition of Friends for the Environment) spoke about how Friends could align with CORE and the benefits which would go with that. Neil Stepped down from the chair and Des Barrett was chairperson while this matter was discussed.

Benefits for Friends from formal affiliation with CORE:

- . Friends would come under the legal protection of CORE. Friends of Sorenson's Garden have been able to get legal aid this way. Therefore individial members of Friends wouldn't be legally liable as they are now because the group is not incorporated.
- . Funding bodies won't be likely to give money to Friends as we are not a legal entity but we could apply for funds/grants through CORE. Friends would still keep own own financial records. CORE would account for monies received through grants. CORE would get payment for bookwork and audit expenses i.e. an administrative fee.
- . Ability to enter into other contracts by getting the incorporation benefits of CORE e.g. if wanting to get a book published.

It is not necessary for all members of Friends to be CO RE members but to be a Local Resident Action Committee of CO RE some Friends' members would have to be nominated to become members of that Committee, thus forming the link between Friends and CO RE.

Friends, acting as a Local Resident Action Committee, would be acting through CORE or speaking As CORE, and would therefore have to use CORE's media release procedure when acting in this way.

Friends need to specify which of our activities/ issues we would see as the function of the Local Resident Action Committee. It would not include everything we do.

Friends have to make formal application to CORE to become affili-

ated, nominating the members of Friends who would be members of the Local Resident Action Committee.

Disadvantages of formal affiliation with CORE:

when Friends act as CORE in the nominated functions of the Local Resident Action Committee we are accountable to CORE and are not a totally autonomous group at that time.

It was agreed that Friends become a Local Resident Action Committee of CORE and to make formal written application.

The members of the Local Resident Action Committee shall be Neil Stuart, Marisha Kreisler and Dianne Jacobus.

The function of this Committee shall be to administer grants received by Friends of Katoomba Falls Creek Valley.

One of the Committee members will act as liasion person with CORE's Co-ordination Committee.

Friends will acknowledge its affiliation with CORE as follows - Friends of Katoomba Falls Creek Valley (CORE).

All of these decisions need to be accepted by CORE's board of Directors (next meeting September 8, 1991)
